BYLAW NUMBER 2025-13

A BYLAW OF THE TOWN OF CENTRAL BUTTE TO CONTROL ANIMALS

The Council of the Town of Central Butte in the Province of Saskatchewan enacts as follows:

DEFINITIONS

1. For the purposes of this bylaw livestock shall mean any domesticated animal ordinarily kept in an agricultural or farm setting, which includes but is not limited to: cattle, horses, sheep, pigs, goats, rabbits, bison, elk, deer, chicken, turkeys, geese, or ducks.

GENERAL

- 1. No person shall keep or herd livestock of any kind or number, at any time within the limits of the Town of Central Butte.
- 2. No person shall keep any snake of any kind or number, at any time within the limits of the Town of Central Butte.

PENALTY AND ENFORCEMENT

- 3. A person who contravenes this Bylaw may be guilty of an offence.
- a) No person shall:
 - i) fail to comply with any provision of this Bylaw;
 - ii) fail to comply with an order made pursuant to this Bylaw;
 - iii) obstruct or hinder any person acting under the authority of this Bylaw; or
 - iv) remove, deface or destroy an order issued pursuant to this Bylaw.

- b) Any person who contravenes or fails to comply with any provision of any part of this Bylaw or fails to comply with an order issued by a designated officer, is guilty of an offence and liable on summary conviction to:
 - i) a fine of \$250.00
- c) A notice of violation issued in contravention of this bylaw shall indicate that the Town will accept voluntary payment in the sum of \$125.00 to be paid to the Town within fourteen (14) calendar days of the initial date of issuance.
- i) Where the Town receives a voluntary payment of the amount prescribed within fourteen (14) calendar days, the person or corporation receiving the notice of violation shall not be liable to prosecution for the alleged contravention.
- ii) Voluntary payment shall not exempt any person from compliance with the provisions of this Bylaw.
- d) A notice of violation may be given or served:
 - i) personally; or
- ii) via Canada Post regular mail to the last known mailing address of the person or corporation being served.
- e) Any payment required pursuant to this Bylaw may be made at the Town Office.
- f) A designated officer may, at their discretion, cancel any notice of violation where that notice or order was issued improperly or in error.

SEVERABILITY

6. Any section, subsection, sentence, clause, phrase or other portion of this bylaw is for any reason held invalid or unconstitutional by a court of competent jurisdiction, that portion shall be deemed a separate, distinct and independent provision and the holding of the court shall not affect the validity of the remaining portions of the bylaw.
